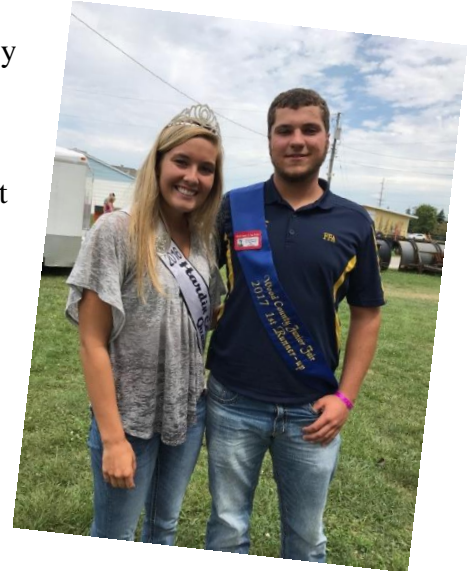
Responsibilities

The Ambassadors will be responsible for the following from July 2019 through July 2020:

- Attending the Gilpin County Fair in 2019 and 2020 and performing activities such as talking to the public, giving out awards, and participating in at least 1 contest/activity.
- Attend at least 4 planning meetings for the Fair.
- Promoting the Fair through interviews, social media and outreach.

Scholarships

The Ambassadors will each receive at least a \$500 scholarship upon the successful completion of the program and completing all responsibilities.



Rules

1. Applicants should be interested in the Gilpin County Fair, our community and interacting with the public.
2. Applicants must be a junior or senior in high school for the 2019-2020 school year.
3. Previous royalty/ambassadors may apply again, although priority will be given to new applicants.
4. Applicants do NOT need to be able to ride horses or have any horse/livestock experience.

Application process

1. Applicants will submit an application.
2. Applicants will be interviewed. Interviews will cover such topics as personal interests, experiences and thoughts about the Gilpin County Fair.
3. Applications and interviews will be scored by a panel.
4. Final Ambassadors will be announced during the 2019 Gilpin County Fair.

Applications due by May 1, 2019.

I understand that negligence includes the failure to do an act, which a reasonably careful person would do, or the doing of an act which circumstances, to protect himself or herself, or others from accident, loss, damage, injury or death. I agree to be solely responsible for my own safety and to take every precaution to provide for the safety and wellbeing of others, while participating in activities or functions sponsored or conducted by the Gilpin County Fair. This release and waiver is given in the interest of permitting the Gilpin County Fair to exist and serve in the community. My release and waiver is given in exchange for my or my child's participation in the Gilpin County Fair programs, events and rides. This release and waiver has no expiration date.

Participants in fairs or other special events, contests or exhibitions do so at their sole risk. Insurance coverage of any type is not provided by the County, its Board of County Commissioners, appointed boards, its employees, its agents or its assigns, regarding any injury, loss or liability that may arise through the participation in fair or special events.

I grant permission to Gilpin County Fair, its employees and representatives, to take and use photographs, videotapes, audio recordings and quoted remarks of me or prepared by me, for use in promotional materials.

I understand this waiver could affect my legal rights and I acknowledge that I have had the opportunity to consult with a lawyer before signing this waiver.
